- **ClubAssist:** Phone and email support for any club-related enquiry, five days a week, 52 weeks a year, helping you to navigate complex issues with confidence — responding to more than 9300 member club enquiries across the year.
- **Media & Marketing:** Crisis support to protect your club's reputation during critical incidents, and supporting member clubs to proactively tell their stories of community support — resulting in over 200 stories in mainstream media over the past year, contributing to record levels of public trust in the industry.
- **Responsible Gambling Management:** Ensuring clubs exceed their compliance obligations in

an ever-evolving regulatory environment, with best practice guidance, access to Multi-Venue Self-Exclusion (MVSE) and counselling through ClubSafe — supporting over 3200 counselling calls and managing more than 7000 exclusions.

- **ClubEducation:** Access to suites of training developed and delivered by industry specialists to ensure directors and managers meet their compliance and governance obligations — with close to 2000 participants attending sessions.
